**STATUS REPORT**

Complainant, EPA, in the above captioned matter, on behalf of the parties, hereby submits this Status Report in response to Ms. Fortin’s email dated on September 24, 2014 which Ms. Fortin transmitted on behalf of Judge Coughlin. In the September 24, 2014 email, Ms. Fortin indicated that the Judge would like Status Reports every two weeks beginning October 8<sup>th</sup> and on October 22<sup>nd</sup> and so on if necessary.

This Status Report updates the October 15, 2014 Status Report submitted to the Judge in regard to the status of the Consent Agreement and Final Order (“CA/FO”) in this matter. On or about October 15, 2014 the Advanced Recovery, Inc. CA/FO signed by Respondent was mailed to EPA. On October 21, 2014, Counsel for Complainant was in receipt of the CA/FO signed by Respondent.

On October 21, 2014, Counsel for Complainant sent the CA/FO signed by Respondent to EPA Region 2’s signatory, the Division Director of our Division of Enforcement and Compliance Assistance (“DECA”), Ms. Dore LaPosta, Complainant. Ms. LaPosta is out on leave this week. Mr. Pat Durack, the Deputy Director of DECA, is also out of the office on travel this week. After EPA’s signatory signs the CA/FO, the remaining step requires the Final Order of the CA/FO be signed by the Regional Judicial Officer, Ms. Helen Ferrara.

Given the foregoing, EPA expects to have the fully executed CA/FO filed with the Court before or by October 31, 2014.


