Reply Supporting Motion to Dismiss

Notwithstanding the United States Environmental Protection Agency’s clarification in its response to Respondent’s Motion to Dismiss, Respondent requests an order dismissing any claims with prejudice based on events alleged to have occurred before September 13, 2007 or, in the alternative, an order confirming that no evidence of alleged violations predating September 13, 2007 will be considered. 28 U.S.C. § 2462; *United States v. Banks*, 115 F.3d 916, 918 (11th Cir. 1997), *cert. denied*, 522 U.S. 1075, 118 S. Ct. 852, 139 L. Ed. 2d 752 (1998); *Britton Construction Co. et al.*, 8 E.A.D. 261, 274-75 (EAB 1999).

WHEREFORE, for the reasons stated above, Respondent respectfully requests an order dismissing any claims with prejudice based on events alleged to have occurred before September 13, 2007 or, in the alternative, an order confirming that evidence of the same will not be considered.


