ORDER GRANTING RESPONDENTS' UNOPPOSED MOTION FOR EXTENSION OF TIME

The hearing in this matter was conducted December 12-18, 2018, in Des Moines, Iowa. Thereafter, electronic copies of the hearing transcript were provided by email to counsel for the parties on January 30, 2019. On January 31, 2019, I issued an Order Scheduling Post-Hearing Submissions, setting post-hearing filing deadlines. The Order Scheduling Post-Hearing Submissions set the filing deadline for Respondents' Initial Post-Hearing brief as April 12, 2019; the filing deadline for Complainant's Reply Post-Hearing Brief as April 26, 2019; and the filing deadline for Respondents' Reply Post-Hearing Brief as May 10, 2019.

On April 9, 2019, Respondents filed an Unopposed Motion for Extension of Time to File Respondents' Initial Post-Hearing Brief ("Unopposed Motion"). In the Unopposed Motion, Respondents request an extension of the filing deadline for Respondents' Initial Post-Hearing Brief to Monday, April 15, 2019, due to scheduling matters involving Respondents' counsel and Respondents. Respondents further represent that Complainant does not oppose the Unopposed Motion.

The rules that govern this proceeding, set forth at 40 C.F.R. Part 22, authorize the Presiding Officer to grant an extension of time for filing of any document for good cause shown upon motion, after consideration of prejudice to the other parties. 40 C.F.R. § 22.7(b). As the Respondents' request for an extension shows good cause and is unopposed, granting it and extending the subsequent filing deadlines is appropriate. Accordingly, the Unopposed Motion is GRANTED, the filing deadline for Respondents' Initial Post-Hearing brief is extended to Monday, April 15, 2019; the filing deadline for Complainant's Reply Post-Hearing Brief is extended to Monday, April 29, 2019; the filing deadline for Respondents' Reply Post-Hearing Brief is extended to Monday, May 13, 2019.
