**COMPLAINANT'S RESPONSE TO RESPONDENT'S  
MOTION FOR EXTENSION OF TIME**

Complainant, by and through its counsel, pursuant to Rule 22.16(b) of the Consolidated Rules of Practice (40 C.F.R. § 22.16(b)) respectfully submits this *Response to Respondent's Motion for Extension of Time*.

Respondent has requested a 90-day extension to file its responses in order to secure counsel. The undersigned, in an email to Michael Mathie dated September 28, 2012, wrote that Respondent may file a motion for an extension of time to answer the complaint and that EPA will not oppose a reasonable request. There was no subsequent discussion between the parties as to what would be a reasonable extension of time. On October 1, 2012, the same day that Respondent signed and mailed its motion, Complainant filed its First Amended Complaint with the Regional Hearing Clerk. The First Amended Complaint was served on Respondent on October 4, 2012. On or about October 11, 2012, Respondent was able to secure counsel.

A reasonable extension of 30 days in order for Respondent to answer the First Amended Complaint should be granted.
