SUPPLEMENTAL JOINT PARTIAL MOTION TO CONFORM THE HEARING TRANSCRIPT AND JOINT MOTION FOR EXTENSION OF TIME TO FILE POST-HEARING BRIEFS

A. Supplemental Joint Partial Motion to Conform the Hearing Transcript

An administrative hearing in the above-captioned matter was held from April 3-5, 2018, in Albany, New York. An electronic copy of the transcript of the testimony given during that hearing was received by counsel for the parties on May 10, 2018. On that same date, this tribunal issued an Order Scheduling Post-Hearing Submissions, which provided that upon review, and pursuant to 40 C.F.R. § 22.25, any party could file a motion to conform the transcript to the actual hearing testimony by June 11, 2018. Upon subsequent joint motions of the parties, and per this tribunal's June 14, 2018 Order Granting Second Joint Motion for Extension of Time, that deadline was ultimately extended to June 22, 2018. On June 22, 2018, the parties jointly moved for over 679 corrections to the 290-page transcript, Complainant separately moved for 11 additional corrections and Respondent separately moved for 21 additional corrections.

On July 10, this tribunal sent the parties audio recordings for most, but not all, of the hearing, with instructions to attempt to agree to additional stipulations for the separately proposed corrections. After reviewing the transcripts, the parties have agreed to stipulate to corrections for 24 of the 32 separately proposed corrections. For the remaining 8 corrections, because the audio recordings are either missing or provide no additional clarification, Complainant continues to rely on the corrections proposed in its June 22 separate motion.

Therefore, in order to ensure that the record in this proceeding comports with 40 C.F.R. § 22.25 and contains a "verbatim" transcript of the testimony provided during the administrative hearing held in the above-captioned matter, the parties respectfully request that their Supplemental Joint Partial Motion to Conform the Hearing Transcript in this proceeding be GRANTED in each of the respects set forth below:

B. Joint Motion for Extension of Time to File Post-Hearing Briefs

Pursuant to 40 C.F.R. § 22.7(b), "[t]he ... Presiding Officer may grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties" Judge Biro's May 10, 2018 Order Scheduling Post-Hearing Submissions, among other things, sets deadlines for the parties' filing of post-hearing briefs. Those deadlines were thrice extended by Judge Biro for good cause, most recently in her June 13, 2018 Order Granting Second Motion for Extension of Time. The next deadline is for Complainant's Initial Post-Hearing Brief, on July 27, 2018.

As the parties have noted in their previous motions for extension, and as described further, above, the review and correction of the transcript in this matter has been especially difficult, given extremely poor transcription on one of the three days and the poor quality and incompleteness of the audio recording. As a result, the parties have had to continue to dedicate significant time to conforming the transcript, including preparation of this supplemental motion, which has continued to delay completion of their post-hearing briefs. Therefore, pursuant to 40

C.F.R. § 22.7(b), upon timely motion, for good cause shown, and on behalf of the parties in this matter, the parties respectfully request that their Joint Motion for Extension of Time to File Post-Hearing Briefs be GRANTED as described below:
