Northeast Quarter of Section 34, Town of Lisbon, Juneau County, Wisconsin May 11, 2012

ATTENDEES: Gregory T. Carlson, U.S. Environmental Protection Agency (EPA)

SITE: Located on either side of U.S. Highway 12, in the NE 1/4, Section 34, Township 16 North, Range 3 East, Town of Lisbon, Juneau County, Wisconsin


CONDITIONS: Mostly sunny, around 65 degrees F.

HISTORY/BACKGROUND: EPA, in preparation for a hearing in the matter of Joseph L. Bollig & Sons, Inc., performed additional observations of water levels and flow within an unnamed tributary that originates in wetlands on the Mauston New Lisbon Union Airport property and flows about one mile to the Lemonweir River, in part, by passing beneath U.S. Highway 12 about 2.3 miles north of the city of Mauston, Wisconsin.

OBSERVATIONS: I parked along the east or northbound shoulder of U.S. Highway 12 on May 11th, around 7:45 a.m. where the unnamed tributary enters a culvert beneath the highway. I walked to the upstream side of the U.S. 12 culvert to check for flow and observe the channel. There was no discernable flow into the culvert or in the channel upstream of it, but the channel and culvert contained significant amounts of water. Photo 1 is an upstream view of the unnamed tributary's channel a few feet upstream of the culvert. I walked the channel upstream as it parallels the highway for about 120 feet and took Photo 2 through overhanging dogwoods and alders as the channel bent away from the highway right of way. Crossing the highway to the downstream side of the highway culvert, I took a couple of photos depicting the sinuous channel at the same spot where data was collected by EPA in October 2009. Photo 3 depicts the first channel bend downstream of the highway culvert and the general location of the channel thalweg measurement in 2009. The channel waters were in flood stage as the water levels exceeded the bank height. Photo 4 depicts a close-up of the channel near the thalweg measurement. The floating grasses at the interface of the open channel waters and the vegetated bank belie the flooding nature of the channel at this point in time. A channel thalweg measurement yielded depths of 33 and 35 inches within six inches of each other. In contrast, the channel thalweg was 16 inches in 2009 and described as bankfull or to the top of the discernable channel bank. Photo 5 depicts the flooded ground between the unnamed tributary channel as it meanders toward the Lemonweir River – note the mirrored water surface within the willow clump in the photo center. Photo 6 depicts the continuation of the channel downstream towards the Lemonweir River. Given the increased water depths from the fall of 2009 to the spring of 2012, the flooded ground on the downstream side of the U.S. 12 highway culvert and the lack of flow even with the increased water levels, likely means the Lemonweir River is in flood stage. If the Lemonweir River is in flood stage, then the observations of the unnamed tributary are depicting back waters of the flood.

EPA departed the site around 8 am.
