**ORDER GRANTING COMPLAINANT’S MOTION FOR EXTENSION OF TIME TO  
FILE CONSENT AGREEMENT AND FINAL ORDER**

By Order dated July 7, 2015, the undersigned set August 21, 2015, as the deadline by which the parties in this proceeding were to file a fully-executed Consent Agreement and Final Order with the Regional Hearing Clerk in the event that the parties had settled this matter. On July 30, 2015, Complainant filed a Status Report and Motion for Extension of Time to File Consent Agreement and Final Order (“Motion”) explaining that “the parties are optimistic that this case will settle” and requesting that the deadline to file a Consent Agreement and Final Order be extended to September 25, 2015, in order to allow for approval of a proposed Supplemental Environmental Project as part of the settlement and to accommodate staff scheduling. In so moving, Complainant states that counsel for Respondent was informed of the Motion, and does not object.

The rules that govern this proceeding, set forth at 40 C.F.R. Part 22, authorize the Presiding Officer to grant an extension of time for filing of any document for good cause shown upon motion, after consideration of prejudice to the other parties. 40 C.F.R. § 22.7(b). As Complainant’s request for an extension shows good cause, Respondent does not object to the extension, and the extension does not otherwise prejudice Respondent, extension of the deadline to file a Consent Agreement and Final Order is appropriate. Accordingly, the Motion is hereby **GRANTED**. The parties shall file a fully-executed Consent Agreement and Final Order on or before **September 25, 2015**.
