





ORDER GRANTING RESPONDENT'S MOTION FOR A 14-DAY EXTENSION TO
FILE A CONSENT AGREEMENT AND FINAL ORDER

By Order issued May 4, 2010, the parties were granted an additional 30 days to file a finalized Consent Agreement and Final Order ("CAFO") in this matter. On June 1, 2010, Respondent filed a status report and a Motion For 14 Day Extension of Time Within Which to File Consent Agreement and Final Order ("Motion"). In that Motion, Respondent states that the parties have exchanged a second draft CAFO, which includes a Supplemental Environmental Project ("SEP"). According to the Respondent, the "language regarding their rights and obligations with respect to the SEP" has created the need for additional time. Motion at 1. Respondent asks for another 14 days within which to finalize the CAFO. The Complainant has filed no objection to the Motion.

For good cause shown, the Respondent's Motion is **Granted**. The parties must file a fully executed CAFO by June 18, 2010. If no CAFO is received by that date, Complainant must file its initial prehearing exchange by June 25, 2010.
