ORDER GRANTING MOTION FOR EXTENSION OF TIME  
TO FILE PREHEARING EXCHANGE

Respondent failed to file his prehearing exchange on or before May 21, 2009, as required by the Administrative Law Judge's Prehearing Order dated March 4, 2009. Therefore, on May 27, 2009, the undersigned issued an Order to Show Cause.

On June 15, 2009, Respondent filed a response to the Order to Show Cause and a request for extension of time to file his Prehearing Exchange.

Pursuant to a teleconference with both parties on July 15, 2009, Respondent is granted an extension of time to file his prehearing exchange.<sup>1/</sup> The new schedule is as follows: Respondent's initial prehearing exchange is due August 21, 2009; and Complainant's rebuttal, if any, is due September 4, 2009.
