- 5) If an Exhibit that is provided as part of the Prehearing Exchange includes tables, charts, graphs and other images that are clearly and legibly included within the Exhibit, the tables, charts, graphs and other images contained therein may be enlarged for presentation or shown on screen during the Hearing without having to separately identify or exchange the enlarged image as an additional Exhibit for purposes of the Prehearing Exchange, provided no other change has been made to the image.
