## ORDER GRANTING SECOND MOTION FOR STAY

By Order issued May 12, 2011, the undersigned extended prehearing filing deadlines in this matter. The only remaining deadline set by that Order is August 26, 2011, which is the date by which Complainant's Rebuttal Prehearing Exchange is due to be filed. After Respondent filed a Motion for an Accelerated Decision on the Penalty Factor for Gravity on August 15, 2011, Complainant moved for an extension of time until September 6, 2011, to file a response, which the undersigned granted per Order issued August 16, 2011.

On August 19, 2011, Complainant filed a Second Motion for Stay ("Motion"), wherein it stated that the parties "have reached an agreement in principle to settle this matter." Noting that Respondent does not oppose the Motion, Complainant requests a thirty day stay of the proceeding so that it may prepare and file an executed Consent Agreement and Final Order ("CAFO").

The procedural rules that govern this proceeding, 40 C.F.R. Part 22, provide that the undersigned may grant a motion for an extension of time to file a document for "good cause" and after considering whether a party may be prejudiced by such extension. 40 C.F.R. § 22.7(b).

The unopposed Motion is hereby <u>GRANTED</u> for good cause shown, and this matter is stayed until September 22, 2011. If a CAFO has not yet been filed, Complainant's Rebuttal Prehearing Exchange shall be filed by September 26, 2011, and Complainant's response to Respondent's Motion for an Accelerated Decision on the Penalty Factor for Gravity shall by filed by October 6, 2011.
