ORDER RULING ON OUTSTANDING MOTIONS

There is currently pending a motion by the Complainant in Docket No. TSCA-(PCB)-VIII-93-26, to withdraw certain allegations from the Complaint. In that motion, the Complainant asks to withdraw, without prejudice, all allegations in the Complaint relating to the homogeneous area of acoustical texture in the boy's dormitory. This would have the effect of lowering the unadjusted penalty to \$140,000, although the adjusted proposed penalty of \$25,000 would not be affected. This motion is unopposed and is granted.

Complainant has also filed a motion to consolidate the above captioned proceedings and has requested that the Prehearing Exchange and other deadlines be extended to conform in these cases. The deadline relief has already been granted and that request, therefore, is moot. With regard to consolidation, it would appear that good cause exists for this action, since the parties are the same in the three proceedings and all the Complaints allege violations of the same statute.




