

ORDER RETURNING CASE TO CHIEF ADMINISTRATIVE LAW JUDGE

As you previously have been notified, the September 4, 2012 Order of the Chief Administrative Law Judge designated the undersigned as a neutral in the Alternative Dispute Resolution ("ADR") process in the above-captioned matter. The November 27, 2012 Order of Consolidation provides that the ADR process terminates December 28, 2012.

The parties have been engaging in settlement discussions as part of the ADR process. Due to the impending retirement of the undersigned, this case is being returned to the Chief Administrative Law Judge for reassignment to another ADR Judge. Final continuation of the ADR process to January 25, 2013 is recommended because the parties' negotiations are ongoing.<sup>1/</sup>


