#### <u>ORDER</u>

The U.S. Environmental Protection Agency ("EPA") has filed a Motion for Default Order requesting that judgment be entered against Adiccom, Inc. ("Adiccom"), and that Adiccom be ordered to pay a civil penalty in the amount of \$79,650. Alternatively, EPA requests that Adiccom be precluded from calling witnesses and introducing exhibits into the record in this proceeding. Adiccom has not filed a response.<sup>1</sup>

EPA moves for a default order because Adiccom has not submitted a prehearing exchange in response to this court's Order Setting Prehearing Procedures, dated September 1, 1999. That order in part stated, "[t]he failure of the respondent to timely file its Opening Prehearing Exchange may result in that party's being precluded from calling witnesses and introducing exhibits into the record."

Given the above language of the prehearing order, EPA's alternative request for relief is *granted*. Accordingly, Adiccom will not be permitted to call witnesses or introduce exhibits at the hearing to be held in this case. Adiccom, however, may still challenge any witnesses and exhibits offered by the other parties.
