## PROVIDING FOR REOPENING AND FOR COMPLAINANT'S STATEMENT OF EVALUATION OF RESPONDENT'S ABILITY TO PAY

Pursuant to the Order entered herein on August 31, 1994, this matter is hereby reopened, and the effect of that Order stayed pursuant to Respondent Sam Emani's oral petition, for the purpose of determining the appropriate penalty to be assessed for violations found pursuant to complainant's motion for "accelerated decision."

Despite the apparent failure or refusal of Respondent Sam Emani to provide tax returns without threat of imposition of the full proposed penalty, and the difficulty of the parties in discussing settlement of the penalty issue, Respondent's plea of inability to pay may now be assessed to some extent owing to Respondent having furnished federal income tax returns for the years indicated in the August 31, 1994, Order.

Counsel for complainant shall file a statement which sets forth its evaluation of Respondent's tax returns and ability to pay the civil penalty proposed in the complaint within fourteen (14) days of the date of this Order. Thereafter, Respondent will be given an opportunity to respond to Complainant's evaluation.
