- Three Quarterly Updates - Dated January, April, and July 2017.
- Validation Report for Immunoassay Method - [Envigo Study Number [HLS0980](#) - Dated 3 May 2016].
- PTU - positive control report - [Envigo Study Number [XJ05HV](#) - Dated 27 April 2017]. Note that this report is also being submitted concurrently through Document Processing Desk.
- Study Update: Dose Range Finding Pre and Post Natal Developmental Thyroid Study in Sprague-Dawley Rats by Oral Administration - [Envigo Study Number [BDG0204](#) - Phase 1 - Dated 23 May 2017]. This was provided to the Agency via email on 30-May-2017 with a request for confirmation of proposed dose levels and timings for hormone measurements. It is important to note that EPA's confirmation is still needed (by Sept 1) in order to proceed with Phases II and III.

In addition, later this week we expect to provide the following summary report:

- Validation for GC-MS/MS - No final report yet, but Envigo will provide a summary with Protocol, Method, Calibration Curves and Results - [Envigo Study Number [FF58YR](#)].

If you could help me address these, it will help ensure that we can have the most productive call possible. See below:

**In the Update on DCPA developmental thyroid studies, it states that updates on this study (presumably Phase 1) were submitted on January 18, 2017 and April 11, 2017. Do you have these submissions? Do those submissions indicate whether they have performed a positive control (PTU) study (to gain expertise in blood sampling of young animals, as stated in 2015 protocol review), and whether there are data to show if direct dosing of pups will be necessary (as stated in the 2015 protocol review)?**

*(Please forward me 1/18/17 and 4/11/17 submissions referenced here if available)*

**Did Envigo send in the protocol for the new LCMS method as well as the calibration curves and stability data that they mention in the Update on DCPA developmental thyroid studies letter? We need to know the sensitivity of the new method.**

*(Please forward me the LCMS method protocol and stability data referenced here if available)*
