Dear Mr. Robinson:

The U.S. Environmental Protection Agency is investigating the land application of biosolids that occurred on property located on Highway 212 in Rosebud County, Montana.

On November 19, 2019, you received a letter from the EPA requesting information about the land application on your property. Your response was due December 3, 2019. To date, the EPA has not received the requested information. Section 308(a) of the Clean Water Act, 33 U.S.C § 1318(a), and Section 3007(a) of the Resource Conservation and Recovery Act, 42 U.S.C. 6927(a), authorize the EPA to require the submission of information necessary to determine whether a person is in compliance with the statutes. **Your response is mandatory.** These statutes allow EPA to seek civil penalties for failing to respond to this information request and criminal penalties for knowingly making a false statement.


