ORDER GRANTING JOINT MOTION FOR SECOND EXTENSION OF TIME TO FILE MOTION TO CONFORM

The hearing in this matter was conducted December 12-18, 2018, in Des Moines, Iowa. Thereafter, electronic copies of the hearing transcript were provided by email to counsel for the parties on January 30, 2019. On January 31, 2019, I issued an Order Scheduling Post-Hearing Submissions, setting post-hearing filing deadlines. The Order Scheduling Post-Hearing Submissions set March 1, 2019 as the filing deadline for any motions to conform the transcript to the actual testimony. Upon joint motion, I extended the filing deadline for motions to conform the transcript to the actual testimony to March 5, 2019, by order dated March 4, 2019.

On March 5, 2019, the parties filed a Joint Motion for Second Extension of Time to File Motion to Conform the Transcript to the Actual Testimony ("Second Joint Motion"). In the Second Joint Motion, the parties request that the filing deadline for motions to conform the transcript to the actual testimony be extended to March 7, 2019, due to the number of necessary changes in the transcript identified by the parties, and their interest in filing such a motion jointly.

The rules that govern this proceeding, set forth at 40 C.F.R. Part 22, authorize the Presiding Officer to grant an extension of time for filing of any document for good cause shown upon motion, after consideration of prejudice to the other parties. 40 C.F.R. § 22.7(b). As the parties' request for a second extension shows good cause and is agreed upon by the parties, granting it is appropriate. Accordingly, the Second Joint Motion is **GRANTED**, and the filing deadline for motions to conform the transcript to the actual testimony is hereby extended to March 7, 2019.
