
**ORDER GRANTING MOTION FOR EXTENSION OF TIME
TO FILE CONSENT AGREEMENT AND FINAL ORDER**

By Initial Prehearing Order dated August 5, 2008, the parties were directed to file a Consent Agreement and Final Order (CAFO) in this matter on or before September 5, 2008. On September 4, Complainant submitted a Motion for Extension of Time (Motion), requesting a ten day extension of time, until September 15, 2008, to file the CAFO. By email dated September 4 forwarded to the undersigned's office, counsel for Respondent stated that the Motion is unopposed.

The Motion states that on August 12, 2008, counsel for Complainant sent counsel for Respondent a final negotiated CAFO, and on September 3, counsel for Complainant was advised that the Respondent had executed the CAFO and that it would be received by Complainant on September 5. The Motion states that Complainant will require several days to obtain concurrences before the CAFO is filed.

The Motion is hereby **GRANTED**. Good cause exists for the granting of the Motion in that it is in the interest of the parties and judicial economy for the parties to settle this matter on mutually agreeable terms rather than litigate the matter to conclusion. In that a hearing in this case has not been scheduled, no prejudice will result from a brief delay.

Accordingly, the parties shall file the fully executed CAFO on or before **September 15, 2008**. The parties are hereby reminded that failure to submit the CAFO in a timely manner may result in entry of an order of dismissal or default, as appropriate, without further notice.




