**ASSENTED-TO MOTION OF RESPONDENT NEW HAMPSHIRE GLASS TO
EXTEND TIME TO FILE ANSWER TO THE COMPLAINT**

New Hampshire Plate Glass Corp., a/k/a New Hampshire Glass ("NH Glass"),
respondent in the above-entitled matter, hereby moves, with the assent of the complainant, for an
extension of the deadline by which it must file its Answer to **May 2, 2013**. In support of this
request, NH Glass states as follows:

1. This action was commenced by the filing of a Complaint on or around January 31, 2013.
2. Upon receipt of said Complaint, NH Glass requested a thirty-day extension of the deadline to file its answer or other responsive pleading, to which the complainant did not object. On February 26, 2013 an Order was issued extending the answer deadline to April 2, 2013.

3. Since that time, the parties have met and exchanged information informally. The parties have agreed that it would be useful for them to have some additional time to confer and to explore the possibility of an amicable resolution before the respondent is required to respond to the Complaint.

4. Accordingly, NH Glass seeks an additional extension of thirty days, to May 2, 2013, to file its answer or other responsive pleading.

4. Counsel for the complainant has indicated her concurrence in the relief sought herein and her assent to the granting of this Motion.

WHEREFORE, respondent New Hampshire Plate Glass Corp. respectfully prays:


A. That its deadline for filing an answer or other responsive pleading be extended to May 2, 2013; and


