Under 40 C.F.R. § 22.16(b), Complainant's reply to Respondent's Response must be filed within 10 days after the Response was filed. However, the hearing in this case is scheduled to begin on May 2, 2022. Thus, to allow time for this Tribunal to consider the Motion and rule on it before the hearing begins, the deadline for Complainant to reply to the Response shall be shortened to 5 days as provided by Section 22.16(b) of the Rules. *See* 40 C.F.R. § 22.16(b) ("The Presiding Officer . . . may set a shorter or longer time for response or reply, or make other orders concerning the disposition of motions").
