STATUS REPORT

Complainant, EPA, in the above captioned matter, on behalf of the parties, hereby submits this Status Report in response to Ms. Fortin's email dated on September 24, 2014 which Ms. Fortin transmitted on behalf of Judge Coughlin. In the September 24, 2014 email, Ms. Fortin indicated that the Judge would like Status Reports every two weeks beginning October 8th and on October 22nd and so on if necessary.

This Status Report was delayed due to the hospitalization of my daughter, from September 25, 2014 through October 3, 2014, which took lead Counsel for Complainant out of the office for that time period to care for her. I hope that the Court finds that this constitutes good cause for the delay in submitting this Status Report.
