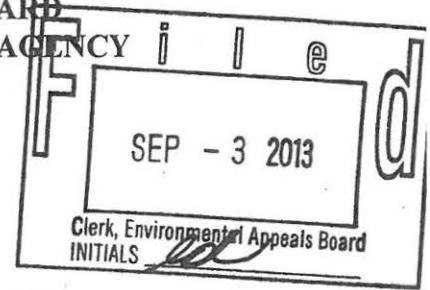

**SECOND ORDER EXTENDING TIME TO FILE  
ANSWER AND REQUEST HEARING**

By motion filed with the Environmental Appeals Board on August 30, 2013, Shanghai Howhit Machinery Manufacture Co. Ltd. (Howhit)<sup>1</sup> seeks an extension of time until September 30, 2013, to file an answer and request a hearing in the above-captioned matter.<sup>2</sup> Unopposed Motion for Extension of Time to Answer Complaint and Request Hearing (“Motion”). In support of the requested extension, the Motion states that “[t]he Complaint contains serious allegations that require substantial investigation by Howhit.” Motion at 1. In addition, the Motion states that Morgan, Lewis & Bockius was only recently retained as counsel

for Howhit. *Id.* The Motion represents that U.S. EPA's Air Enforcement Division, the Complainant in this matter, does not oppose the requested extension. *Id.* at 2.

For good cause shown, the Motion is granted. An answer and request for hearing must now be filed with the Headquarters Hearing Clerk no later than September 30, 2013.
