### ORDER GRANTING MOTION FOR ISSUANCE OF SUBPOENAS

On February 24, 2009, Complainant submitted Complainant's Motion for Issuance of Subpoenas ("Motion") pursuant to Section 11(c) of the Toxic Substances Control Act ("TSCA"), 15 U.S.C. § 2610(c). Complainant seeks subpoenas for the appearance and testimony of Suzanne Long and Darren M. Parmer at the hearing.

Section 22.21(b) of the Rules of Practice, 40 C.F.R. §22.21(b), authorizes the Administrative Law Judge to issue subpoenas under certain circumstances to require the attendance of witnesses or the production of documents at a hearing. Pursuant to Section 22.21(b), "[t]he Presiding Officer may require the attendance of witnesses or the production of documentary evidence by subpoena, if authorized under the Act, upon a showing of the grounds and necessity therefor, and the materiality and relevancy of the evidence to be adduced."

Upon consideration of Complainant's unopposed Motion and for good cause shown in accordance with 40 C.F.R. § 22.21(b), the Motion will be granted. Respondent has shown sufficient grounds and necessity for the subpoenas and the materiality and relevancy of the proposed evidence to be adduced. Accordingly, Complainant's Motion is **Granted**.
