ORDER OF DESIGNATION

Washington, D.C. 20004. Documents filed electronically should be submitted online using the OALJE-Filing System.¹ The Regional Hearing Clerk may properly reject any documents that a party attempts to file in the Regional Office while this matter is before the Administrative Law Judge.
