The U.S. Environmental Protection Agency (EPA) Region 5, hereby gives notice that it is proposing to assess a civil penalty of \$60,000.00 against Joseph L. Bollig & Sons, Inc. (Bollig) for violating the Clean Water Act. EPA filed *In re Joseph L. Bollig & Sons, Inc.*, Docket No. _____, wherein it seeks civil penalties from Bollig for discharging pollutants, in the form of dredge material and organic debris, without a permit into approximately seven (7) acres of wetland at the Mauston-New Lisbon Union Airport, owned by the cities of Mauston and New Lisbon, Wisconsin. The property site and wetlands are located within the watershed of the Lemonweir River in the east half of the southeast quarter of the southeast quarter of Section 28, Township 16 North, Range 3 East, Lisbon Township, Juneau County, State of Wisconsin. In addition, Bollig is being charged with failing to respond to a Clean Water Act Section 308 Request for Information regarding this site.

Any person who wishes to comment on the proposed penalty order must submit written comments to the Regional Hearing Clerk at the address listed below, within 30 days of the date of this notice. The comments should identify the case name and docket number.

Any person who wishes to participate in these proceedings must submit his or her name and complete mailing address, and a statement that he or she wishes to participate in the proceedings to the Regional Hearing Clerk within 30 days of the date of this notice. Only the respondent, Bollig, may request a hearing on the proposed penalty order. If EPA holds a hearing, the presiding officer will give notice of any hearing to any person who notified the Regional Hearing Clerk of his or her wish to participate.

You may obtain a copy of EPA's administrative complaint from the Regional Office at the address listed above. The administrative record, including documents filed by respondent, are on file at the Regional Office and open for public inspection between 9:00 a.m. and 4:00 p.m., Monday through Friday.
