COMPLAINANT'S REQUEST FOR A STATUS CONFERENCE

The Complainant hereby requests that the Presiding Officer convene a status conference, to be conducted by telephone, at her convenience. This request is occasioned by the following:

1. As of November 10, 2010, the parties completed the prehearing exchange as required by 40 C.F.R. § 22.19 and the Presiding Officer's Order.
2. The Presiding Officer has set this matter for hearing on March 1, 2011.
3. Respondent's Prehearing Exchange includes evidence establishing that Respondent's principal, Laurence C. Kelly, is personally liable for the treatment of spent lamps without a RCRA permit. In view of that, Complainant has arranged for Mr. Kelly to receive a standard Pre-filing Notice of Liability letter contemporaneously with this Request.
4. As noted in Complainant's Initial Prehearing Exchange, Complainant learned after filing the Complaint that Respondent's principal, Laurence C. Kelly, is the president of a newly-organized corporation, S.L.R. Technologies, Inc.,


which currently engages in the unpermitted treatment of spent mercury lamps. Information gathered to date suggests the new corporation's activities are in material respects similar to, or the same as, those Respondent is alleged to have engaged in.

5. Based on the foregoing, Complainant intends to move for leave to amend the Complaint to add additional parties.
6. Complainant expects to complete her investigation of S.L.R. Technologies, Inc., in the next approximately thirty days, barring evasion or recalcitrance, and to move for leave to amend the Complaint promptly thereafter.

Complainant also expects then to be in a position promptly to supplement her Prehearing Exchange, so that this matter can proceed with dispatch.

Wherefore, Complainant respectfully requests a telephone conference, so that the Presiding Officer and the parties can discuss the appropriateness of a schedule for a Motion for Leave to Amend, a Motion for Accelerated Decision on Liability, and a rescheduled hearing. While Complainant intends the conference to be addressed to procedural matters, her attorneys are prepared to apprise the Presiding Officer more fully of the circumstances.
