**COMPLAINANT’S MOTION TO CONFORM THE TRANSCRIPT OF THE HEARING TO THE
ACTUAL TESTIMONY**

The Director of the Air Enforcement Division of the U.S. Environmental Protection Agency’s Office of Civil Enforcement (“Complainant”) files this Motion to Conform the Transcript of the Hearing to the Actual Testimony consistent with section 22.25 of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits (“Consolidated Rules”), and with the Post-Hearing Scheduling Order issued by this Tribunal on November 1, 2017. Complainant has conferred with respondents’ counsel, and as of time of filing had not heard whether counsel would oppose this Motion.

1. The hearing in this matter was held on October 17, 18, and 19, 2017.
2. The Tribunal issued the Post-Hearing Scheduling Order on November 1, 2017, which stated that the Hearing Clerk of the Tribunal received the official transcript of testimony taken at the hearing on October 30, 2017.
3. A complete copy of the transcript was made available by email Complainant received on November 1, 2017 from Matt Barnwell, Attorney-Advisor, Office of Administrative Law Judges.
4. The transcript of the testimony taken at the hearing contains typographical errors and inaccuracies.
5. This motion is submitted by Complainant in a timely manner in that it is being filed on or before November 17, 2017, the deadline provided by the Tribunal in the Post-Hearing Scheduling Order. 40 C.F.R. §22.25 states, in pertinent part, that “any party may file a motion to conform the transcript to the actual testimony within 30 days after receipt of the transcript or 45 days after the parties are notified of the availability of the transcript, whichever is sooner.”

6. Attached hereto as Exhibit A is a table listing by page and by line the corrections to the transcript that will conform the transcript to the actual testimony presented at the hearing. Making these corrections is necessary to ensure that the transcript is accurate and understandable.
