

SUPPLEMENTAL ORDER ON RESPONDENT’S MOTIONS FOR EXTENSION OF TIME

On November 22, 2017, this Tribunal issue an Order on Respondent’s Motions for Extension of Time. That Order postponed the hearing date and modified certain prehearing deadlines.

The Tribunal supplements the November 22 Order solely to extend the time within which Respondent may file a response to Complainant’s Motion for Partial Accelerated Decision on Liability. The rules governing this proceeding, set forth at 40 C.F.R. Part 22, allow the Presiding Officer to “grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties.” 40 C.F.R. § 22.7(b). Having previously found it appropriate to grant Respondent’s Motions, the Tribunal extends Respondent’s deadline to file its response to Complainant’s Motion for Partial Accelerated Decision on Liability from November 24, 2017, to December 11, 2017.
