Environmental Protection Agency, Region 5 (Complainant or U.S. EPA), pursuant to 40 C.F.R.

§§ 22.16 and 22.14(c) of the Consolidated Rules of Practice Governing the Administrative

Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits

(Consolidated Rules or Rules), submits that on January 7, 2011, she received Respondent's

Memorandum in Support of Complainant's Motion for Leave Amend the Complaint and

Compliance Order. In it, Respondent does not oppose the proposed amendments that Mr.

Laurence C. Kelly be added as a Respondent and that certain regulatory citations be replaced.
