Dear Mr. Trivisvavet:

Enclosed is a Complaint and Notice of Opportunity for Hearing for the assessment of a civil administrative penalty against Syngenta Seeds, LLC, doing business as Syngenta Hawaii, LLC, for violations pursuant to Section 14(a) of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA). Specifically, the Complaint will allege that Syngenta Seeds has violated Section 12(a)(2)(G) of FIFRA, 7 U.S.C. § 136j(a)(2)(G), by using a registered pesticide in manners inconsistent with its labeling. This action will allege that Syngenta Seeds did not comply with the Worker Protection Standard, set forth at 40 C.F.R. part 170, in a number of ways, including but not limited to: (1) failing to prevent workers from entering a treated area where a pesticide had been recently applied; (2) failing to notify workers of recent pesticide applications; (3) failing to provide reasonably accessible decontamination supplies to workers; and (4) failing to make available prompt transportation to an appropriate emergency medical facility for exposed workers.

You should be aware of the part of the Complaint entitled "Opportunity to Request a Hearing." You are required to respond to this Complaint within thirty (30) days of receipt of the Complaint. If you fail to file an Answer to this Complaint with the Regional Hearing Clerk within thirty (30) days of receipt, your failure shall constitute an admission of all facts alleged in the Complaint and a waiver of your right to a hearing. The proposed civil penalty shall become due and payable sixty (60) days after a final order is issued upon default.
