COMPLAINANT'S INITIAL PREHEARING EXCHANGE

Complainant, the United States Environmental Protection Agency (EPA or the Agency), respectfully submits Complainant's Initial Prehearing Exchange pursuant to Rule 22.19(a) of the Consolidated Rules of Practice, 40 C.F.R. § 22.19(a), and the Prehearing Order of Presiding Officer Susan L. Biro, dated July 5, 2018.

I. FACT AND EXPERT WITNESSES AND BRIEF NARRATIVE SUMMARY OF EXPECTED TESTIMONY

Complainant may call any or all of the following witnesses at a hearing of the above-captioned matter. Complainant notes that some of the testimony below may be rendered unnecessary by stipulations or by rulings on dispositive motions. It is Complainant's intent to promote judicial efficiency by resolving factual matters through stipulations or dispositive motions where possible.

Witnesses

Akash Johnson, U.S. EPA, Region 8, Office of Enforcement, Compliance and Environmental Justice. Mr. Johnson is a Clean Water Act Inspector and Case Development Officer in the Clean Water Act Technical Enforcement Program within the Office of Enforcement, Compliance and Environmental Justice, and serves as the lead

Inspector and Case Development Officer for the EPA's enforcement action against the Respondents. Mr. Johnson is expected to testify as a fact witness regarding the U.S. EPA's August 31, 2016 storm water compliance evaluation inspection of the Frostwood Townhomes project located in Park City, Utah, pursuant to UPDES Construction Storm Water Permit No. UTR373147, as well as EPA's August 9-10, 2018 reconnaissance inspection. He is also expected to testify regarding storm water runoff from the site, the discharge of contaminated storm water into waters of the United States, MS4 conveyances, and surface waters near the Site. Additionally, Mr. Johnson is expected to testify as an expert witness as to the calculation of the EPA's proposed civil penalty in this matter, based on the facts of this case and the application of U.S. EPA General Enforcement Policy #GM-21, dated February 16, 1984, and U.S. EPA General Enforcement Policy #GM-22, dated February 16, 1984. A copy of Mr. Johnson's curriculum vitae is attached as CX 43.

Emilio Llamozas, U.S. EPA, Office of Enforcement, Compliance and Environmental Justice. Mr. Llamozas is a Clean Water Act Inspector in the Clean Water Act Technical Enforcement Program within the Office of Enforcement, Compliance and Environmental Justice, and serves as an Inspector for the EPA's enforcement action against the Respondents. Mr. Llamozas is expected to testify regarding U.S. EPA's August 31, 2016 storm water inspection of the Frostwood Townhomes project located in Park City, Utah, pursuant to UPDES Construction Storm Water Permit No. UTR373147. He is also expected to testify regarding storm water runoff from the site.

Kyle Monez, Summit County. Mr. Monez is an engineer technician with the Summit County Department of Public Works. Mr. Monez is expected to testify regarding

site visits and inspections. He is also expected to testify concerning Municipal Separate Storm Sewer System (MS4) conveyances and surface waters near the Site, and his knowledge of the area including storm water run-off from the Site. Additionally, he is expected to testify regarding communications with Respondents about permit requirements.

Jeanne Riley, Utah Department of Environmental Quality, Division of Water Quality. Ms. Riley is the program manager for the Division of Water Quality's Storm Water Section and also serves as an inspector for the program. Ms. Riley is expected to testify regarding the State of Utah's April 28, 2017 storm water inspection of the Frostwood Townhomes project located in Park City, Utah. She is also expected to testify concerning the State's processing of Respondents Frostwood 6 LLC and David Jacobsen Construction's filing of the 2017 Notice of Intent.

Ann Czerwonka, Special Consultant, Industrial Economics. Ms. Czerwonka holds a Bachelor of Arts with academic honors in Mathematics with an Economics Complement from Wellesley College and a Master of Business Administration with concentrations in Finance, Quantitative Methods and Organizational Behavior from the Tuck School of Business at Dartmouth College. Ms. Czerwonka is expected to testify as an expert witness regarding Respondents' ability to pay claim and supporting documentation. A copy of Ms. Czerwonka's curriculum vitae is attached as CX 42.

III. TIME TO PRESENT CASE AND TRANSLATION SERVICES

Complainant's preferred hearing location is Salt Lake City, Utah. Complainant estimates that presenting the direct case will take two (2) days. Complainant needs no translation services.

IV. DOCUMENTATION OF SERVICE

Documentation showing service of the complaint was completed in accordance with Section 22.5(b)(1) of the Consolidated Rules of Practice is attached as CX 38, CX 40 and CX 41.

V. NARRATIVE STATEMENT EXPLAINING ALLEGATIONS

Complainant included summaries of witness testimony and exhibits to support the factual and legal bases for the allegations denied or otherwise not admitted in Respondents' Answer.

Complainant notes that Respondents have stipulated to the fact that Complaint ¶12 contains a typographical error and should read "EPA regulations state regulated storm water discharges include discharges from small construction activity. 40 C.F.R. § 122.26(a)(9)(i)(B)." Counsel for Respondents stated that Respondents admit to the corrected Complaint ¶12, as written above.

Complainant also confirmed with counsel for Respondents that Answer ¶54 contains a typographical error, and the parties stipulated that Answer ¶54 should say Respondents did not accept the Expedited Settlement Agreement.

VI. INFORMATION AND DOCUMENTATION SUPPORTING PENALTIES

In proposing the amount of civil penalty in this matter, the Clean Water Act requires the EPA to take into account the applicable statutory factors, which according to section 309(g)(3) of the Act, 33 U.S.C. § 1319(g)(3), are "... the nature, circumstances, extent and gravity of the violation, or violations, and, with respect to the violator, ability to pay, any prior history of such violations, the degree of culpability, economic benefit or savings (if any) resulting from the

violation, and such other matters as justice may require." Complainant has included summaries of witness testimony and documentation in its proposed exhibits that support the civil penalty based on the applicable statutory factors.

VII. GUIDANCE, POLICIES, AND PREAMBLES

In developing the proposed civil penalty to be specified in Complainant's Rebuttal Prehearing Exchange, Complainant intends to rely upon the following Agency guidance documents to account for the Act's penalty factors: EPA's General Enforcement Policy #GM-21 (CX 1) and A Framework for Statute-Specific Approaches to Penalty Assessments: Implementing EPA's Policy On Civil Penalties #GM-22 (CX 2). These penalty policies calculate civil penalties based on the economic benefit accrued, gravity, degree of willfulness and/or negligence, cooperation or noncooperation, and other legal and equitable factors. Gravity evaluates the seriousness of the violations by in three applicable categories: (1) determining the actual or possible harm by evaluating the amount of pollutant, sensitivity of the environment, toxicity of the pollutant and length of time the violation(s) continued; (2) the importance of the violated requirement to the regulatory scheme; and (3) addressing recordkeeping and reporting requirements based on the availability of the data to the EPA from other sources. Generally, for a discharge without a permit violation, the level of actual or potential harm is evaluated on the seriousness scale as moderate to major depending upon the length of violation and sensitivity of the waters where the discharges occurred. For permit violations of non-numeric effluent limitations, the level of actual or potential harm is evaluated based on the length of violation, the sensitivity of the waters where the discharges occurred, and impact on the amount of pollutants discharged. For the second category, the importance of the violated requirement to the regulatory scheme, discharge without a permit is also generally evaluated on the seriousness scale as

moderate to serious depending upon the length of violation. Violations of conditions of a permit are evaluated for seriousness in the second category by evaluating importance of the violations to the regulatory scheme. Generally, permit condition recordkeeping violations are determined as minor to moderate violations on the seriousness scale depending upon whether the information is available from other sources. The violations are determined to be major violations if the information is not available from another source.

Complainants listed other guidance, policies, and preambles as exhibits, above.

VIII. PROOF OF PUBLIC NOTICE

EPA is required to provide the public with the opportunity to comment on the proposed administrative Class II penalty under the Clean Water Act, as provide by 33 U.S.C. § 1319(g)(4)(A) and 40 C.F.R. § 22.45(b). Documentation of EPA's July 11, 2018 Public Notice of Opportunity to Comment on the Proposed Administrative Penalty Assessment against Respondents is attached as CX 57.

X. PAPERWORK REDUCTION ACT

The Paperwork Reduction Act is not applicable to an enforcement proceeding under the Consolidated Rules of Practice.

XI. RESERVATIONS AND REBUTTAL SUBMISSIONS

Complainant respectfully reserves the right to supplement its list of witnesses upon adequate notice to the Presiding Officer and Respondents, and to call such witnesses at the hearing of this matter should Respondents' Initial Prehearing Exchange or other discovery reveal the need for further witnesses to rebut Respondents' case. Complainant reserves the right to cross-examine any witnesses offered by Respondents.
