¹ Two individuals submitted public comments in this matter under 40 C.F.R. § 22.45(c)(1)(iii), which allows for persons to present written comments for the record at any time prior to the close of the record. Section 22.45(c)(1)(ii) provides that the "Presiding Officer shall provide notice of any hearing on the merits to any person who has met the requirements of paragraph (c)(1)(i) of this section at least 20 days prior to the scheduled hearing. Paragraph (c)(1)(i), in turn, provides that "[a]ny person wishing to participate in the proceedings... must provide his name, complete mailing address, and state that he wishes to participate in the proceeding." 40 C.F.R. § 22.45(c)(1)(i) (emphasis added). The commenters have not stated a desire to participate in this proceeding. However, it is in the public interest that I am providing them this notice.
