

REPORT RECOMMENDING CONTINUATION
OF ALTERNATIVE DISPUTE RESOLUTION PROCESS

The Report approved March 6, 2015 provides that this alternative dispute resolution (ADR) process terminates April 6, 2015. The recommendation of this Report is that the ADR process be continued for a final month, to May 6, 2015.

This continuation of the ADR process is recommended because the parties' negotiations have developed a settlement in principle but additional time is needed for the preparation and filing of the Consent Agreement and Final Order ("CAFO"). In a conference call on April 2, 2015 the parties stated their agreement on continuing the ADR process for the final month.

The parties are commended for their success in negotiating their agreement. The undersigned further expresses her appreciation to the parties for the courtesy and candor with which they participated in the ADR process.
