## ORDER ON JOINT MOTION TO CONFORM THE TRANSCRIPT

The hearing in this matter was conducted December 12-18, 2018, in Des Moines, Iowa. Thereafter, electronic copies of the hearing transcript were provided by email to counsel for the parties on January 30, 2019. On January 31, 2019, I issued an Order Scheduling Post-Hearing Submissions, setting post-hearing filing deadlines. Consistent with the post-hearing filing deadlines, as extended by prior orders, the parties filed a Joint Motion to Conform the Transcript ("Joint Motion") on March 7, 2019, along with a Table of Transcript Errata ("Errata Table"), marked as Exhibit A to the Joint Motion. In the Joint Motion, the parties request that the transcript be modified with the proposed corrections reflected in the Errata Table to conform the transcript with the actual testimony at the hearing.

I have reviewed the changes to the transcript proposed by the parties in the Errata Table, and I find such corrections to the transcript appropriate with the following modifications:

- a. the proposed correction of "flows" for "follows" in line 6, on page 329 of the transcript, corrects only the second occurrence of the word "follows" in line 6, on page 329;
- b. the proposed correction for lines 9-10, on page 60 of the transcript, reflected on page 6 of the Errata Table, actually corrects lines 9-10 of page 460; and
- c. the proposed correction for lines 14-15, on page 630 of the transcript actually corrects lines 13-14, on page 630.

Therefore, the Joint Motion is **GRANTED** subject to the foregoing modifications, and the record of the evidentiary hearing is hereby modified accordingly.
