**REPORT RECOMMENDING CONTINUATION  
OF ALTERNATIVE DISPUTE RESOLUTION PROCESS**

The Order by Chief Administrative Law Judge Biro, dated February 21, 2018, that initiated this alternative dispute resolution (“ADR”) process provided for a termination date of April 23, 2018. A recommendation was made and approved on April 10, 2018 that extended ADR until May 23, 2018. The recommendation of this Report is that the ADR process be continued for an additional 30 days, until June 25, 2018. Throughout this time, I will continue to serve as a Neutral in this matter.

This continuation of the ADR process is recommended because the parties’ negotiations are ongoing and additional time is needed to finalize settlement discussions. Several conferences have already taken place and a final joint conference is scheduled to take place on June 25, 2018. In the interim, should additional conferences be desired by the parties, I will be pleased to make myself available to assist with settlement negotiations.
