GREAT LAKES DREDGE & DOCK COMPANY, LLC'S NOTICE OF SUPPLEMENTAL AUTHORITY RELEVANT TO ITS MOTION TO DISMISS

Respondent Great Lakes Dredge & Dock Co., LLC ("Great Lakes") hereby provides Notice of Supplemental Authority in connection with its Motion for Dismiss. Undersigned counsel has recently become aware of *United States v. Blankenship*, 382 F.3d 1110 (11th Cir. 2004), in which the Eleventh Circuit stated (in the context of a criminal case) the general rule that "[i]t is not illegal for a party to breach a contract; a contract gives a party two equally viable options (perform or pay compensation), between which it is generally at liberty to choose. A 'promise' contained in a contract is ... a grant of a legal right by the other party to either enjoy performance or receive damages. ... Moreover, a party has the power to waive its rights under a contract – that is, a party may choose not to enforce a contract if the other side breaches." *Id.* at 1133-34. This case supports Great Lakes' argument in its Motion to Dismiss that an alleged breach of the contract between the U.S. Army Corps of Engineers and Great Lakes gives rise only to contract-based remedies, and is not otherwise a violation of law that may be the basis for the U.S. Environmental Protection Agency to impose civil penalties under the MPRSA. *See* also Robert C. Herd & Company v. Krawill Machinery Corp., 359 U.S. 297, 304-05 (1959)

(statutes are not to be construed to derogate common law unless they clearly say so).
