RESPONDENT'S FIRST AMENDED PREHEARING EXCHANGE

Borla Performance Industries, Inc. ("Borla" or "Respondent"), through counsel, files this First Amended Prehearing Exchange, consistent with section 22.19 of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits ("Consolidated Rules"), and with the Prehearing Order issued by the Presiding Officer on October 19, 2020. Respondent may amend or supplement this First Amended Prehearing Exchange as provided by sections 22.19(f) and 22.22(a)(1) of the Consolidated Rules.

Pursuant to the Prehearing Order issued on October 19, 2020, supplements to prehearing exchange submissions may be made without an accompanying Motion to Supplement the Prehearing Exchange if the scheduled hearing is more than 60 days after the date of the supplemental filing. The hearing has not been scheduled. As such, Respondent believes this filing is timely.

Respondent is adding the following potential witness to its Prehearing Exchange:

<u>Jason Isley</u>: Mr. Isley is an active participant in amateur road racing and autocross and has won several Sports Car Club of America national championships since he started competing in 1993. Mr. Isley was also previously employed at Racer Media & Marketing Inc., North America's largest, independent general interest motorsports publisher. Mr. Isley's wife, Jennifer

Isley, is also an accomplished racer. Mr. and Mrs. Isley own a converted racing vehicle, a Mazda Miata purchased as a street vehicle and converted by Mr. and Mrs. Isley to a racing-only vehicle with aftermarket parts including a Borla exhaust system part that was included among the Borla parts alleged to be in violation in the instant case. Mr. Isley may testify regarding the steps necessary to convert a street vehicle to a racing vehicle, as well as the specific steps taken to convert the Isley's Miata into a racing-only vehicle, including the installation of the Borla exhaust part, removal of safety and comfort equipment, and other changes made to complete the conversion. Mr. Isley may also testify regarding the use of the vehicle including the transportation of the racing vehicle to and from events/repairs on a trailer and observations regarding other vehicles at the races he has attended.
