#### ORDER ON JOINT MOTION FOR EXTENSION OF TIME

On June 13, 2017, I issued the Prehearing Order in this proceeding, setting forth various prehearing filing deadlines and procedures. On August 14, 2017, the Director of the Division of Enforcement and Compliance Assistance of the United States Environmental Protection Agency, Region 2 ("Complainant") filed a Joint Motion for Extension of Time ("Joint Motion") on behalf of the parties. The Joint Motion requests a seven-day extension to the deadline for the filing of Complainant's Rebuttal Prehearing Exchange, and a 30-day extension to the deadline for the filing of dispositive motions regarding liability. The Joint Motion explains that the "causes for the requested extensions are the complexity of, and large record in, this matter, as well as the summer vacation schedules of key staff needed to prepare the subject filings." Joint Mot. at 1.

The rules governing this proceeding, set forth at 40 C.F.R. Part 22, allow the Presiding Officer to "grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties." 40 C.F.R. § 22.7(b). The Joint Motion was timely, demonstrates good cause, and is agreed upon by the parties, and therefore, granting it is appropriate. Accordingly, the Joint Motion for Extension of Time is hereby **GRANTED**. Complainant shall file and serve its Rebuttal Prehearing Exchange by **September 8, 2017**, and any dispositive motions regarding liability shall be filed and served by **November 8, 2017**.
