JOINT STATUS REPORT REGARDING SETTLEMENT AND MOTION TO EXTEND THE STAY OF THE PROCEEDINGS

On May 1, 2024, the Presiding Officer issued an Order granting a seventh stay, until August 2, 2024, in the above-captioned proceeding. As reported during the previous stays in this matter, the public comment period on the CDA was completed, and no comments were received. DOJ filed a Motion to Enter the CDA on November 9, 2023. The Parties are now waiting for the District Court to act on the Motion. To date, the District Court has not acted on the Motion to Enter and therefore the Parties believe that an extension of the existing stay is appropriate.

Pursuant to 40 C.F.R. § 22.16 and the Prehearing Order, and in the interest of judicial economy and the conservation of scarce government resources, the Parties, jointly request an extension of the stay of the proceeding until November 1, 2024. The further stay of this proceeding will give the District Court additional time to act on the Motion to Enter the CDA. Upon entry of the CDA, Complainant intends to withdraw this matter as moot.
