STATUS REPORT

In response to Chief Administrative Law Judge Biro's February 3, 2021 Prehearing Order ("Prehearing Order"), the U.S. Environmental Protection Agency, Region 10 ("Complainant") submits this Status Report. The Prehearing Order directed the parties to "engage in a settlement conference on or before February 19, 2021, and attempt to reach amicable resolution of this matter."

Complainant contacted Respondent by email on February 5 and February 16, 2021 and asked to schedule a settlement conference. On February 16, 2021, Respondent replied and informed Complainant that Respondent was unable to meet until February 22, 2021. Complainant agreed and the parties held a conference call on February 22, 2021. During that conference, the parties had a productive discussion about the details of this matter, but have not yet reached a settlement agreement

MOTION FOR EXTENSION OF TIME

Complainant respectfully requests this Tribunal grant a one-month extension on all dates and deadlines provided for in the Prehearing Order. 40 C.F.R. § 22.7(b) provides that "the Presiding Officer may grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties."

In Respondent's January 27, 2021 Response to Complaint and Notice of Opportunity for Hearing ("Answer"), Respondent raised its inability to pay a civil penalty. *See* Answer at ¶5.4. Respondent has
