## ORDER TO SUBMIT STATUS REPORTS

From March 26, 2014, to July 28, 2014, the parties participated in the Office of Administrative Law Judges' ("OALJ") Alternative Dispute Resolution program ("ADR"). On August 1, 2014, the neutral ALJ presiding over the ADR reported that the parties "reached a settlement in principle," however, they "have not reached a final agreement." Accordingly, the neutral ALJ recommended that the matter be held in abeyance pending the parties' execution of a Consent Agreement and Final Order ("CAFO"). On August 1, 2014, the undersigned was designated to preside.

Upon consideration of the parties' settlement efforts, this proceeding shall be held in abeyance for a limited period of time. Complainant is hereby **ORDERED** to file reports as to the status of the CAFO, without stating any specific terms of the settlement, on or before August 22, 2014, September 5, 2014, and September 19, 2014.
