MOTION FOR EXTENSION OF TIME


Comes now Complainant, U.S. Environmental Protection Agency, and Respondent ('the Parties'), by and through their respective counsel, pursuant to Rule 22.7(b) of the Consolidated Rules of Practice (40 C.F.R. § 22.7(b)) and respectfully request a 30 day extension of time on behalf of both Parties, in order to attempt successful resolution of the above captioned matter through continuation of the Alternative Dispute Resolution (ADR) process, and for good cause therefor state as follows:

The Parties have successfully made use of the ADR process thus far and achieved limited success in approaching a good faith settlement in principle. Pursuant to discussions before (and the advice of) the Mediator-ALJ on December 14, 2011, in this matter, the Parties hereby request a 30-day extension of time of the ADR process until January 17, 2012. The Parties believe that this extension of time may sufficiently aid the process of negotiations towards an equitable and timely resolution of the above captioned matter.

Prior to filing this Motion, the undersigned contacted the opposing party as to the extension requested herein and said opponent indicated that it does not oppose the Motion and that it may be considered a Joint Filing.
