



NOTICE OF SERVICE

On the morning of December 30, 2015, Complainant filed its Response to Respondents' Motion to Quash and Dismiss Pursuant to Federal Rule of Civil Procedure 12(b)(5) ("Response"). The Response and its exhibits contain material claimed by Taotao USA, Inc., Taotao Group Co., Ltd., and Jinyun County Xiangyuan Industry Co., Ltd., (collectively "Respondents") to be confidential business information ("CBI") pursuant to 40 C.F.R. § 2.203(b). 
