
ORDER GRANTING MOTION FOR EXTENSION OF TIME

Respondent has filed an unopposed Motion for Extension of Time seeking an additional 21 days in which to answer the Complaint in the above-captioned matter. Pursuant to the previous Order, the due date for the answer was January 22, 2013.¹ Respondent has stated that the parties are engaged in settlement negotiations and the additional time is necessary for financial records to be analyzed.




