**MOTION FOR FURTHER EXTENSION OF
PREHEARING DEADLINES**

Pursuant to the Prehearing Order issued November 9, 2023 (Docket Item # 7) (Prehearing Order) and subsequent Orders granting extensions of the Prehearing Deadlines (Docket Items #10 and # 12), Complainant, through Counsel, submits this Motion for Further Extension of Prehearing Deadlines. Complainant respectfully requests a 28-day extension of the deadlines set out in the February 6, 2024 Order (Docket Item # 12) for submission of the Parties' Prehearing Exchanges and Complainant's Rebuttal Prehearing Exchange. Complainant's Counsel has sent an email to Respondents regarding this motion, but has not received a response.

In support of this Motion, Complainant states that the Parties have reached an agreement in principle to resolve this matter without further litigation and are in the process of reducing that agreement to a written Consent Agreement and Final Order (CAFO). The Parties expect to be able to file an executed CAFO with the Regional Hearing Officer with a copy filed with the Office of Administrative Law Judges no later than April 5, 2024. Accordingly, Complainant

respectfully requests an extension to the Prehearing Exchange deadlines set forth in the December 12, 2023 Order as follows:
