AMENDED UNOPPOSED MOTION FOR FURTHER EXTENSION OF PREHEARING DEADLINES

Pursuant to the Prehearing Order issued November 9, 2023 (Docket Item # 7) (Prehearing Order) and subsequent Orders granting extensions of the Prehearing Deadlines (Docket Items #10, #12, and #14), Complainant, through Counsel, submits this Amended Unopposed Motion for Further Extension of Prehearing Deadlines. Complainant respectfully requests a 28-day extension of the deadlines set out in the March 7, 2024 Order (Docket Item # 14) for submission of the Parties' Prehearing Exchanges and Complainant's Rebuttal Prehearing Exchange. Complainant's Counsel has conferred with Mrs. Powers, who indicates Respondents do not oppose this motion.

In support of this Motion, Complainant states that the Parties have reached an agreement in principle to resolve this matter without further litigation and are in the process of reducing that agreement to a written Consent Agreement and Final Order (CAFO). Unfortunately, it has taken
