In response to your November 3, 1998 request for additional information, please be advised of the following information regarding the chemical which is subject to the submission: The chemical name is 7-acetyl-1,1,3,4,4,6-hexamethyl-1,2,3,4-tetrahydronaphthalene and the synonym 2-acetyl-5,6,7,8-tetrahydro-3,5,5,6,8,8-hexamethylnaphthalene are both listed under CAS Registry Numbers 1506-02-1<sup>1</sup> and 21145-77-7. The chemical name used for both of these CASRNs is 2-Acetonaphthone, 5,6,7,8-tetrahydro-3,5,5,6,8,8-hexamethyl-(8CI).

Data from two searches of the CAS Registry are provided to support these statements.




