Dear ms. Wedge:

In response to your letter of March 17, 1988 about 2B Tech, I would like to respond as follows:

1. Aceto imports 2B Tech in the range of 150-250 MT/yr. We do not presume to estimate the quantity of domestic production or of importation by other companies.
2. 2B Tech is used almost exclusively for the production of pigment Red 48 by diazotization and coupling with b-oxy-naphthoic acid. You have already received our MSDS.
3. We do not have, nor are we aware of, any unpublished toxicity data.
4. We have no data on occupational exposure. Potential for exposure in the production of this material only occurs during discharge from the reactor followed by blending and packaging. As 2B Tech is of intrinsically low toxicity, efforts at controlling occupational exposure are concentrated on more hazardous materials.
5. 2B Tech is only likely to be released to the environment due to spills. As we have not had any experiences with spills, we do not have any environmental data.
