Proposed Issuance of Clean Air Act Permit Program (Title V) Permits to
BP – Wood River Terminal, Wood River and
International Mill Service Inc., Alton

BP – Wood River Terminal has requested a Clean Air Act Permit Program (CAAPP) permit from the Illinois Environmental Protection Agency (Illinois EPA) for air emissions from its bulk petroleum terminal located at 335 South Old St. Louis Road in Wood River. As a major source of air emissions, the company is required by the 1990 Amendments to the Clean Air Act to obtain a CAAPP permit. The permit will be enforceable by the United States Environmental Protection Agency, as well as the Illinois EPA. The beginning of this public comment period also serves as the beginning date of the USEPA 45 day review period, provided the USEPA does not seek a separate proposed period. This permit may contain terms and conditions established pursuant to Title I of the federal Clean Air Act thereby making it a combined CAAPP and Title I permit. The Illinois EPA is accepting comments on the draft permit.

International Mill Service Inc. has requested a Clean Air Act Permit Program (CAAPP) permit from the Illinois Environmental Protection Agency (Illinois EPA) for air emissions from its slag processing facility located at 25 Hull Lane in Alton. As a major source of air emissions, the company is required by the 1990 Amendments to the Clean Air Act to obtain a CAAPP permit. The permit will be enforceable by the United States Environmental Protection Agency, as well as the Illinois EPA. The beginning of this public comment period also serves as the beginning date of the USEPA 45 day review period, provided the USEPA does not seek a separate proposed period. This permit may contain terms and conditions established pursuant to Title I of the federal Clean Air Act thereby making it a combined CAAPP and Title I permit. The Illinois EPA is accepting comments on the draft permit.
